Scope 3 consists of, Upstream Transport and distribution, waste generated in operations, Business travel and employee commuting. Upstream transport and distribution accounts for 96% of our Tco2E.

Completed Carbon Reduction Initiatives

Since the inception of the Net Zero project LINET uk have had a renewal of our company vehicles and have imposed an emissions limit of 150g/km. The next review will be in 2026 where we will review what the guidelines are at that stage and with the improvements in technology set a new emissions limit.

We use a broker for our energy who review our energy use and put us with the most appropriate supplier, we will now include the purchasing of green energy as a factor in the selection.
